
Cancellation & Miscellaneous Expenses

- BEC is not liable for any cancellation expenses incurred by the host MA or the participating MAs as a result of the host and/or the participating MA cancelling their participation in the MEP after the date of signature of this agreement. The hosting MA and the participating MA shall be responsible for agreeing between them, in advance of the MEP, how such cancellation expenses shall be handled between them.
- BEC is liable for cancellation expenses reasonably incurred by the hosting MA as a result of BEC cancelling its participation in the MEP after the date of signature of this agreement provided the hosting MA has taken reasonable steps to reduce or eliminate such expenses.
- In the event that BEC and the hosting MA agree that the MEP should be cancelled or postponed as a result of coronavirus or any other force majeure event (including any act of God, fire, flood, storm, war, riot, civil commotion, terrorism, epidemic or explosion) the reasonable costs of cancellation or postponement shall be shared between the hosting MA and BEC in equal parts provided that the hosting MA, the participating MAs and/or BEC take reasonable steps to reduce or eliminate such costs.
- BEC is not liable for any unforeseen expenses on site. When this occurs, the expenses shall be shared equally between the hosting MA and the participating MA
